# 04 CHARGES AND FEES

we categorize our services into Standard and Non-Standard Services, in which the firm has three methods for charging legal fees depending on the nature of the assignment.

#### (i) TIME CHARGE

This is an hourly billing system, whereby an assignment is billed having regard to the time legal counsel spends on the assignment. This does not apply to litigation assignments. A standard fee of equivalent to 50 US Dollar per Hour is charged exclusive of disbursement fees such as fees or charges paid to the government or other authorities in connection with the assignment, telephone or fax charges, etc.

#### (iii) AGREED FEES:

Legal fees for commercial, corporate and preparation of legal instruments such as con-tracts, agreements, conveyances, deeds orother instruments, is determined by mutual agreement with the client before commencement of the assignment.



#### (iii) STATUTORY FEES:

All assignments that involve litigation are billed in accordance with the remuneration stipulated under the Advocates remuneration rules, which prescribed a descending scale of fees from 10% to 3% depending on the value of the subject matter in court.

Allthe above-mentioned charges and fee are subject to negotiation with the client. The firm usually requests a reasonable deposit to be made at the commencement of the assignment enable us meet various disbursement as required for the performance of the assignment
